Location

The site occupies a prominent location fronting Ulverston Road adjacent to Crooklands Garden Centre and approximately 100 yds from the Dalton roundabout. Access to the centre of Dalton, Ulverston and Barrow in Furness is very convenient with the Dalton bypass ultimately giving access to the M6 motorway at Junction 36 some 30 miles to the East.

Description

Our clients have started a development of a range of units which will be either for sale, or to let. They are of steel portal frame construction having blockwork lining either rendered or clad with local stone and a pitched roof covered with insulated profile steel sheeting incorporating translucent roof lights. All the units benefit from roller shutter doors to the front elevation. Eaves height 16' 6".

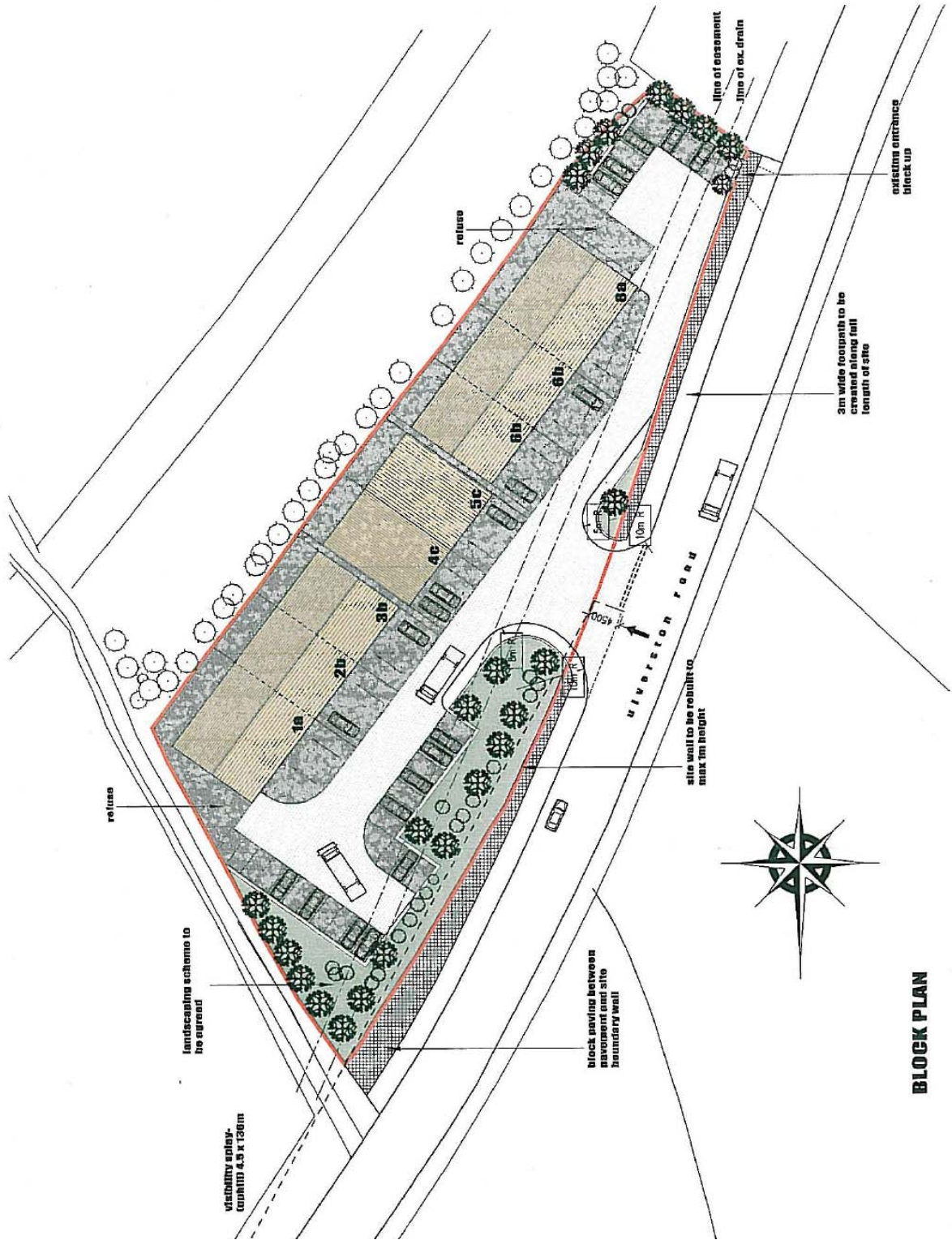
VAT
