Kendal is an attractive market town situated on the edge of the Lake District and known as the gateway to the Lakes being situated approximately 20 miles north of Lancaster, 33 miles from Barrow in Furness, 60 miles from Carlisle and 8 miles from access to the M6 motorway at Junction 36. The town has a resident population of approximately 25,000 but draws on a wider catchment population from a number of villages and affluent rural hinterland.



Location

The available property is situated on Fell View Trading Estate which is on the Shap Road industrial estate to the north of Kendal town centre, and the main trading / industrial estate for the town. Other occupiers on the estate include Kentdale Jaguar/Land Rover, Lakeland Distribution Centre, Kendal Auto Body, EK Motor Factors, and a range of local warehouse/trade counter occupiers.

Description

The property comprises a single story warehouse/trade counter unit with concertina door to a height of approximately 3.0 metres, door width of 3.0 metres, internal eaves height of approximately 4 metres and a small office/reception area to the front; there is a wc to the rear, and on site car parking is available immediately in front of the premises, together with shared estate parking immediately opposite.
