Kendal is an attractive market town situated in South Cumbria on the fringe of the Lake District National Park and known as the Gateway to the Lakes. The town which has a resident population of approximately 40,000 draws on a much wider catchment incorporating surrounding towns and villages. Kendal is a popular market town and tourist destination throughout the year.



Location

The property, which is shown for identification purposes edged red on the enclosed ordinance survey sheet extract is situated in an excellent trading location close to multiples such as White Stuff, Phase Eight, Nevis Sport and Nationwide Building Society but also close to a number of strong independent traders.

Description

The property comprises a shop arranged over ground and first floor sales with wc facilities at first floor level. Historically, the property has been combined with a small unit fronting New Shambles which is also available to let on a separate lease.

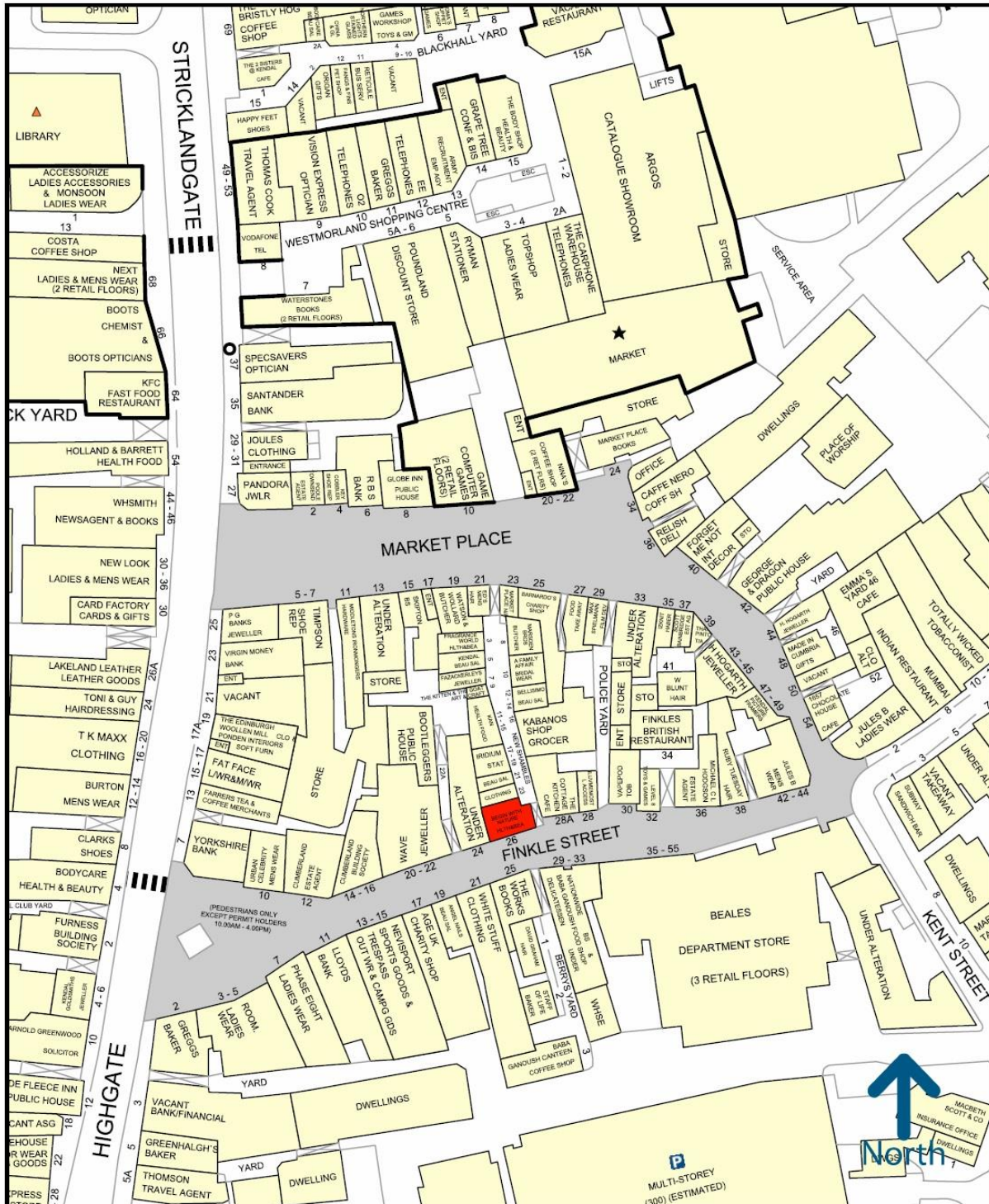
